* At the time of writing (June 2023), [Fees for driver licensing](#) are currently under review as they were last agreed in 2004.

- Patients should note that **not** all documents need the signature of a doctor (e.g. passport application forms). The application form lists other people in positions of trust who are able to sign such documents **free of charge**.
- Bus Pass and Blue Badge forms do **not** need to be completed by a doctor. Patients can complete and submit the forms themselves - only if the application was refused might the patient want to ask the doctor to provide additional information to support their application.
- Patients are advised that any documentation to be completed by a doctor may, in general, take approximately 5 - 7 working days (dependent upon the availability of the doctor concerned and any factors such as annual leave, sickness, etc.)
- If a service you require is not on this list please enquire at Reception. If we are able provide the service, we will advise the fee payable.
- Our list of fees will be reviewed and updated annually.
